MISSION94 MEMBERSHIP AGREEMENT

As of	(the "Effective Date"), I,	(the
"Member," "I," "my" or	"me"), enter into this charter membership agreement, tog	gether with Schedule A and any other
attachments (the "Cor	ntract") with Mission94 Firearms Education Center LLC, a \	Wisconsin limited liability company
("Mission94"), with ref	ference to the following:	

- A. Mission94 operates an indoor shooting range facility known as the Mission94 Firearms Education Center located at 1487 120th Ave, Kenosha, WI 53144 (the "Range") and offers certain benefits and privileges to charter members of the Range.
- B. I wish to become a Member of the Range, subject to the terms and conditions of this Contract.

Therefore, I agree as follows:

- **1. Membership.** I agree to be bound by and to abide by this Contract as well as the bylaws and rules of the Range, as now in effect and as Mission94 may amend in the future.
- 1.1. *The Range's Rules & Operations*. Mission94 will have the absolute right to add, change, or eliminate the Range's bylaws, rules, facilities, services, programs, membership plans, and hours of operation and I shall abide by the same.
- 1.2. Nature of Membership. I acknowledge and agree that my membership is a contractual nonexclusive license to access and use the facilities at the Range during its hours of operation and to enjoy the benefits specified in this Contract, associated Schedule(s), and the Range's bylaws & rules. I further acknowledge and agree that this Contract and my membership does not create any property or leasehold interest in the Range and that my membership has no cash value. If the Range stops operating, I understand that Mission94 will not refund any Membership Fee(s) and/or any Recurring Fee(s) and will not make any payments to me.
- **2. Benefits.** As a Member of the Range, I will enjoy the benefits of the specific Plan which I have purchased as defined in Schedule A (Updated 09/12/2024). I acknowledge and agree that Mission94 has the absolute right to add, change, or eliminate the Range's membership Plans at any time without notice.
- **3. Dues.** Upon executing the Contract, I shall pay any application, setup, or premium fee(s) (the "Join Fee") and/or the initial Recurring Fee (the "Recurring Fee") to Mission 94.
- 3.1. If I am an active Individual, Individual Plus, or Family level member of the Pritzker Military Museum and Library (the "PMML") in Kenosha, Wisconsin, the Join Fee for a Charter Membership will be reduced by 5%.
- 3.2. I shall also pay any required Recurring Fees to Mission94 per the payment terms of my selected Membership Plan. I acknowledge and agree that Mission94 may increase or decrease the Recurring Fee from time to time. I shall pay any applicable sales or use taxes due on my payment of the Join Fee, the Recurring Fee, and any other fee.
- **4. Term.** My membership in the Range will begin on the Effective Date and will renew for the term defined in Schedule A (Updated 09/12/2024) upon my payment of the Recurring Fee.
- **5. My Covenants.** I acknowledge and agree that my membership and this Contract are subject to the following covenants & conditions.
 - A. I and my guests shall obey all of the Range's bylaws and rules while using the Range. I shall be responsible for all actions taken by my guests at the Range.

- B. I shall watch the Range's range safety video and review the Range's safety rules before using any firearms at the Range and shall cause my guests to do the same.
- C. I shall complete the Range's firearms safety course before bringing any guests to the Range.
- D. I shall execute a waiver, release, and assumption of risk prior to my admission to the Range and shall cause my guests to do the same.
- E. I shall indemnify Mission 94 against all property damage or personal injuries to my guests at the Range and against all property damage or personal injuries caused by my guests at the Range.
- F. I shall lawfully transport and store all firearms that I bring to the Range and shall cause my guests to do the same.
- G. I shall abide by all Range Safety Officer guidance, all Range policies, and processes.
- H. I shall immediately report any unsafe behavior to the Range Safety Officer and report any unsafe or concerning events or behavior immediately to management.
- **6. My Representations & Warranties.** I make the following representations and warranties to Mission94 now and for the duration of my membership and the Contract.
 - A. I am capable of safely handling, loading, using, and discharging all firearms and ammunition that I intend to use at the Range.
 - B. All firearms and ammunition that I intend to use at the Range will be suitable for use at the Range.
 - C. All ammunition that I intend to use at the Range is suitable for the firearm in which I intend to use it.
 - D. I am lawfully able to possess and use firearms in Wisconsin and the United States of America.
 - E. I am the lawful owner of or have lawful possession of all firearms that I will bring to, use at, or store at the Range.
 - F. I will comply with all laws applicable to the ownership and possession of all firearms that I will bring to, use at, or store at the Range, including but not limited to federal and Wisconsin law.
 - G. I will ensure all my guests comply with all of the above statements as well.
 - H. Any children that I bring to the range will remain under my direct supervision and will remain my responsibility.
- 7. Termination of Membership. Mission 94 may terminate this Contract and my membership in the Range if:
 - A. I fail to timely pay any required Join Fee(s) or Recurring Fee(s).
 - B. I or my guests violate or breach a covenant in section 5, representation or warranty in section 6, any other term or condition of this Contract, or any other bylaw or rule as they may be amended from time to time.
 - C. I or my guests engage in behavior at the Range that Mission 94 deems to be unsafe
 - D. I notify Mission94 in writing that I wish to terminate my membership per the terms of my selected Membership Plan as defined in Schedule A (Updated 09/12/2024).

The termination of membership will be effective on the date specified by Mission94. I acknowledge that Mission94 will have absolute discretion as to the termination of my membership.

- **8.** Transfer of Membership. I acknowledge and agree that my membership's transferability is defined in Schedule A (Updated 09/12/2024) and that I will abide by all limitations, requirements or restrictions defined therein. I further acknowledge and agree that Mission94 may eliminate entirely the ability to transfer my membership or impose additional rules, conditions, fees, procedures and/or limitations on the transfer of membership and I shall abide by the same, in each case.
- **9. Assumption of Risk.** As a Member of the Range, I may participate in activities that include, but are not limited to, the use and discharge of firearms, the use and discharge of rental firearms provided by the Range, and classes and training provided by the Range. I acknowledge that shooting activities are inherently hazardous and involve both known and unanticipated risks that could result in damage or destruction of property and physical or emotional injury, whether apparent or latent, including loss of limb, paralysis, or death, to myself or other persons. These risks include but are not

limited to: being shot by or shooting myself or others; partial or total loss of eyesight or hearing; tinnitus; inhalation, exposure or other harmful contact with lead, smoke, fumes and/or other hazardous materials and/or contaminants; and being struck by flying or falling objects. I further understand that discharging firearms and using ammunition have inherent dangers that no amount of care, instruction, or expertise can eliminate. I further acknowledge that the Range is an indoor shooting facility which may utilize safeguards to prevent injuries and property damage, but those safeguards may not, in every instance, contain bullets, fumes, or bullet fragments that could cause serious personal injury or death. I further acknowledge and understand that Mission94 makes no warranties as to the design, manufacture, condition, or fitness for any particular purpose of any of the Range's facilities or equipment, including, but not limited to: firearms, ammunition, eye, and hearing protection, and first-aid supplies. I specifically assume any and all risks associated with bringing any child(ren) to the range.

10. Disclaimer of Warranties. Mission94 makes no representations or warranties as to the current or maximum number of members that it has or will have. Mission94 expressly disclaims any representations or warranties regarding the same. I acknowledge and agree that Mission94 may increase or decrease the number of memberships of the Range in its sole discretion and that Mission94 may offer different privileges, benefits, or conditions to other members of the Range in its sole discretion.

11. Facility Use.

- 11.1. Damages. To the fullest extent permitted by applicable law, I will be held responsible to Mission94 and its officers, directors, employees, agents, affiliates, successors and permitted assigns for any and losses, damages, liabilities, deficiencies, claims, actions, suits, judgments, settlements, interest, awards, penalties, fines, costs or expenses of whatever kind, including reasonable attorney's fees, that are incurred by Mission94 (collectively, "Losses"), arising out of any damages caused to the Range, its equipment, personnel, inventory, and materials of any kind as well as lost revenue that resulted from damages caused, directly or indirectly, by myself or my guest(s).
- 11.2. *Lockers*. I understand that lockers, locker access, and acceptable use terms and conditions in that regard are solely defined by Mission94. Mission94 may limit and/or discontinue providing lockers, locker access, and/or redefine the use terms and conditions at any time. I understand and agree to all terms, conditions, access privileges as defined for the membership I select as defined in this Contract.
 - (A) Only members may rent lockers at the Range, based on availability.
 - (B) All lockers are available on a first come, first served basis.
 - (C) Locker rental renews yearly, unless cancelled in writing at least 30 days prior to my renewal date.
 - (D) If Mission 94 agrees, in its sole and exclusive discretion, I may rent a locker at the Range as follows:
 - (1) All locker key(s) remain the sole ownership of Mission94 and must be surrendered upon request by Mission94 and its approved employee(s).
 - (2) I will be provided the only two (2) keys to the locker per membership (not per member).
 - (3) I may not duplicate or in any way reproduce my locker key without written permission from Mission94.
 - (4) If *any* of my assigned key(s) are lost or stolen, I will pay the current Key Replacement Rate to Mission94 for rekeying the locker(s) as defined in this Contract and Schedule A (Updated 09/12/2024).
 - (5) All damages for locker use are subject to all previously defined damage liabilities in this Contract.
 - (6) No illegal items may be stored in Range locker(s).
 - (7) I am responsible for all item(s) stored in my locker(s).
 - (8) Item(s) stored in locker(s) are done so at my own risk; Mission94 is not responsible for and is indemnified by me against all losses that result from my locker storage.
- **12. Biometric Data.** Mission94 uses Biometric Devices at the Range that collect Biometric Data. The Biometric Devices scan, store, and compare Biometric Data to verify my identity in order to control access to Secured Areas. As a condition

of becoming a Member, I voluntarily consent to an initial scan of my Biometric Data by Mission94 and additional scans each time I attempt to access a Secured Area.

12.1. Definitions.

- (A) "Biometric Data" or "Biometric Data" Digitized or computer data obtained by a Biometric Device based on body measurements and calculations related to human characteristics, using identifiers that are distinctive and measurable to individuals. Biometric Data includes fingerprints, iris scans, retinal scans, palm prints, facial and hand geometry, and other similarity scores used to verify or identify individuals.
- (B) "Biometric Devices" A technology that measures Biometric Data and can authenticate an individual's identity.
- (C) "Secured Areas" Area of the Range that Mission94 has designated as accessible only by certain members of the Range according to the privileges of their membership. Biometric Devices control access to Secured Areas. Mission94 has designated its locker rooms and VIP lounge as Secured Areas and may designate additional areas of the Range as Secured Areas at its sole discretion, per section 1.1 of the Contract.

12.2. Disclosure & Acknowledgements.

- (A) I acknowledge and agree that my Biometric Identifier is necessary to gain access to Secured Areas permitted by my membership and my Biometric Identifier will be scanned each time I attempt to access a Secured Area and compared to the Biometric Identifier created by the initial scan of my Biometric Identifier.
- (B) I acknowledge and agree that Mission 94 has the sole discretion to determine which areas of the Range are Secured Areas and which Secured Areas I may access according to the privileges of my membership.
- (C) I acknowledge that Mission 94 may allow me to access different or additional Secured Areas, which will also require my Biometric Identifier to be scanned or compared each time I access those Secured Areas.
- (D) I acknowledge that Mission94 will store and use my Biometric Identifier during the time that I am a member of the Range and for one year after I cease being a member.
- (E) I consent to the use, processing, storage, retention, disclosure, redisclosure, or other dissemination of my Biometric Identifier by Mission94 and/or its vendors that provide and maintain the Biometric Devices and in the course of any investigation by Mission94, which may include disclosure to law enforcement authorities.
- (F) I acknowledge receipt of a copy of Mission94's Biometric Information Policy.
- 12.3. My Responsibilities. I shall take reasonable precautions to prevent any unauthorized or fraudulent use of my Biometric Identifier, which include, but are not limited to:
 - (A) Keeping my Biometric Identifier safe and avoiding any actions that would allow another person to use my Biometric Identifier;
 - (B) Notifying Mission 94 if I am aware of or suspect any unauthorized use or scan of my Biometric Identifier as soon as reasonably practicable. After this notification, I will rescan my Biometric Identifier as required by Mission 94.

I shall be liable for all losses if I do not comply with my obligations or any security measures under this section, Mission94's rules, and other security information or recommendations provided to me by Mission94 from time to time.

- 12.4. Warranties. Mission 94 makes no representations or warranties regarding the accuracy or availability of any Biometric Devices. I will use the Biometric Devices as-is, where-is, as-available, and at my own risk.
- 12.5. *Indemnification*. I shall indemnify, defend, and hold harmless Mission94 from any civil or criminal liability, charge or investigation resulting from allegations involving violations of biometric privacy rights pertaining to Biometric Identifiers provided to Mission94.

13. Renewal.

13.1. Membership Renewal. Your Membership with the Company is a renewing arrangement that will continue for one (1) year, pursuant to this Agreement. After the expiration of one (1) year, your Membership Fees will be automatically recollected, continuing at the same Membership Level and at the same frequency (yearly or bi-weekly) for another one (1) year of Membership with the Company, and this cycle will repeat itself (i) at the sole discretion of the Company or (ii) unless you opt-out of Membership, after notice, at least thirty (30) days prior to your anniversary join date with the Company.

14. Miscellaneous.

- 14.1. Assignment. I may not assign or transfer in my membership in the Range or rights under this Contract except as provided in Section 8 and Schedule A (Updated 09/12/2024).
- 14.2. Consent to Texts, Email Messages and Calls. I consent to receive SMS (including text messages), email messages and calls from Mission94 or anyone acting on its behalf. I certify, warrant and represent that the contact information that I have provided is mine, and is up to date. I agree to notify Mission94 of any changes in my contact information as soon as practicable. Standard message and data rates may apply to all communications.
- 14.3. Waiver. The waiver by or failure of either party to act with respect to any breach of any term, covenant or condition contained in this Contract, will not be a waiver of the term, covenant or condition, or subsequent breach of the same, or any other term, covenant, or condition.
- 14.4. *Survival*. The indemnification provisions set forth in this Contract will survive the expiration or earlier termination of the Contract.
- 14.5. Governing Law and Venue. This Contract will be interpreted under the laws of Wisconsin, without regard to its conflicts of law rules. The exclusive venue for any dispute arising from this Contract, including claims for personal injuries arising from the use of the range, shall be the Kenosha County Circuit Court, even though another venue may be more convenient for the parties or their witnesses. All parties consent to the exercise of personal jurisdiction by the Kenosha County Circuit Court for the resolution of such disputes.
- 14.6. Amendments In Writing. Except for additions, modifications, or deletions to the Range's bylaws, rules, facilities, services, programs, and hours of operation, no amendment, modification, or alteration of this Contract is binding unless in writing, dated after the Effective Date, signed by you and by a duly authorized representative of the Range.

 Notwithstanding the foregoing, this Contract may be amended solely by Mission94 by a writing which specifically states that it is amending this Contract, so long as a copy of such amendment is delivered to you, and provided that, except as otherwise expressly provided in Schedule A (Updated 09/12/2024) for my selected Membership Plan, no such amendment materially adversely affecting your rights hereunder may be made without your written consent. Without limiting the foregoing, Mission94 reserves the right to change, by written notice to you, the provisions of this Contract in any way it may deem necessary or advisable to carry out the purpose of the Contract as a result of any change in applicable laws or regulations or any future law, regulation, ruling, or judicial decision, provided that any such change

Facsimile or electronically scanned copies shall constitute enforceable original documents.

Transfer of Membership. Only Charter Memberships may be transferred.

1.1. Conditions:

- A. If Mission 94 agrees, in its sole and exclusive discretion, I may transfer my Charter Membership to a third party as follows:
 - i. I must notify Mission94 in writing of my intent to transfer my Charter Membership.
 - ii. Transfers of Charter Memberships shall first be offered by Mission 94 to persons on the waiting list, in the order in which they have been waiting.
- iii. The third party must submit a membership application to Mission94 and Mission94 must approve them as the transferee of my Charter Membership.
- iv. The third party must be approved for Membership at the sole discretion of Mission94.
- v. The third party must execute a Charter Membership agreement with Mission 94 and pay the Initial Fee to Mission 94.
- vi. Charter Membership transfers must go through Mission 94 and cannot be sold independently or privately.
- vii. Charter Membership transfers will be processed in the order in which charter members advise Mission94 of their desire to transfer their Charter Membership.
- viii. Transfers of Charter Memberships shall be at the then current Initial Fee.
 - ix. Upon receipt of the Join Fee from the third party, Mission 94 shall retain \$1,000.00 or twenty percent, whichever is higher, and pay the balance of the third party's Join Fee to me.
 - x. If my Charter Membership was terminated pursuant to section 7, I must notify Mission94 in writing within one year of the date that Mission94 terminates my Charter Membership of my desire to transfer my Charter Membership. My failure to abide by the terms of this condition will result in a complete forfeiture of my Charter Fee.
 - xi. I acknowledge and understand that, notwithstanding the above provisions, Mission94 may unilaterally terminate the ability to transfer Charter Membership in its sole discretion.

My signature indicates I acknowledge and agree that Mission94 may impose additional rules and procedures on the transfer of Charter Memberships and shall abide by the same.

- D. Free range time every day of the week for Member*.
- E. Free rentals of non-National Firearms Act firearms*.
 - i. Subject to availability.
 - ii. Mission94 ammunition must be used on the Range.
- F. One (1) free Group Training.
 - i. One (1) hour course length.
 - ii. Includes Member plus 3 Guests.
- iii. Excludes CCL Training.
- iv. Choice of USCCA certified course or historic firearms class.
- G. One (1) free private lesson.
 - i. One (1) hour lesson length.
 - ii. Provided by Mission 94 Instructor.
- iii. One on One Training.
- H. 10% Off Training Classes.
- I. Free Guest Passes, annually*.
 - i. Ten (10) Guest Passes annually available upon anniversary.
 - (a) Yearly Maintenance Fee must be paid prior to Guest Passes being issued on anniversary of joining.
 - ii. Shared Lane.
- J. One (1) free firearm cleaning per visit*.
 - i. Basic cleaning only.

1.5. Facility Benefits:

- A. Access to the Range's private members' only VIP lounge for members and guest(s).
 - i. Parties larger than four (4) require reservation at least twenty-four (24) hours in advance.

 - ii. Unlimited borrowing from the eMaterial collection of eBooks.
 - iii. Access to the physical library located in Kenosha, Wisconsin.
 - iv. Member may book appointments for a private library reading room.
 - v. Free regular admission for one (1) to the Museum & Library.*
 - vi. 10% Discount at the gift shop (in person and online).
- vii. Advanced notification and registration for upcoming programs and events.
- viii. 20% Discount on regular programs and events for one (1) at the Museum & Library.*
- ix. Invitations to exclusive VIP and Member Only events.
- x. Free regular admission for one (1) to the National WWII Museum in New Orleans.*

1.7. Non-Accrual:

A. I understand that benefits marked with * do not accrue. I acknowledge that if I do not use these benefits within the specified window, they will lapse and expire.

1.8. Locker Key Replacement Rate:
